## Minutes of the Council Meeting held on 23 September 2024

- 1. Apologies:** Councillors G Chapman, G Chaplin and C Corner.
- 2. To agree the Minutes of the last Parish Council Meeting:**  
The minutes of the meeting held on the 22 July 2024 were agreed and signed by the Chairperson.
- 3. North Yorkshire Council Report:** It was reported that the Enforcement Notice on the Dog and Gun has been overturned by the Planning Appeal Expectorate. Consideration is being given to changing the speed limit on Station Road and Carlton Road to 30 miles per hour for the whole stretch of the road.
- 4. Clerk's Report:** Communication was sent from the Parish Liaison at North Yorkshire and this was emailed to all Councillors. Yorkshire Water informed the Council of upcoming work on Carlton Road in conjunction with Highways which will commence on 1 October 2024 until the 12 November 2024. This will be manned from 7.00am to 7.00pm each day.
- 5. General Parish Matters:**  
A new defibrillator has been purchased and installed. There is some difficulty in accessing the box and Councillor Nickson will look into this. It was suggested that pads for children be purchased for the defibrillator. This was agreed. Clerk to action.
- 6. Highways:** Councillor C Corner has contacted Highways Officer D Griffiths to ask for the cost of 2 lamp post screens to drop around the 3 posts before deciding to purchase.
- 7. Planning Applications:** Planning Ref: ZB24/01769/FUL – Proposed alterations to Carr House, Carlton Road, Carlton Miniott. This was discussed and the Council has no objections. Clerk to action.
- 8. Planning Decisions:** None.

9. **Playing Field:** It was reported that the cost of repairing the zip wire will be in the region of £1,000.00p. It was reported that there are no funds to cover this and new volunteers are urgently needed to take over the running of the Association and raise funds.
